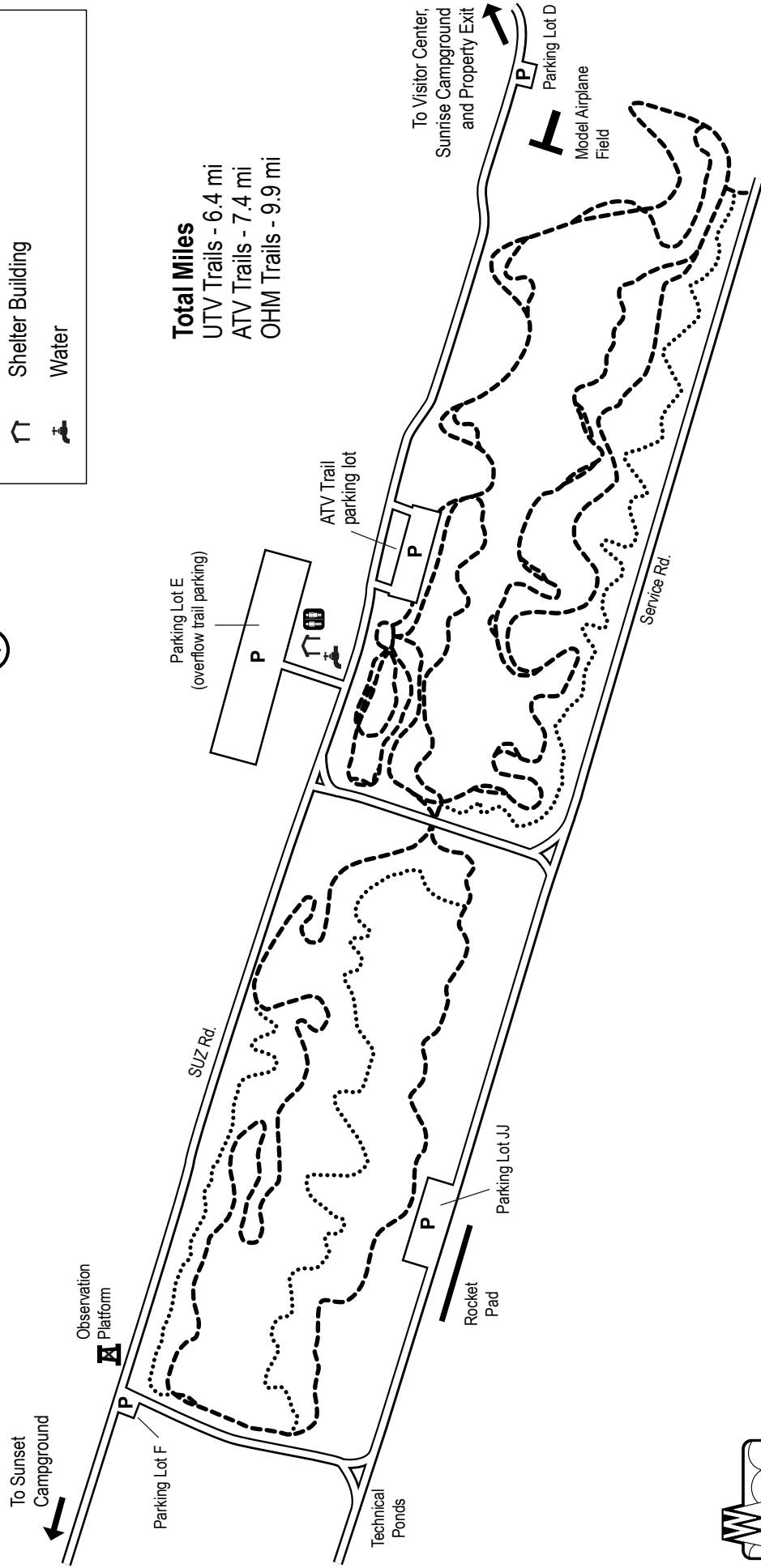

# RBSRA ATV / UTV / OHM Trail Information and Rules

## GENERAL RULES

1. **Call (262) 878-5600 (ext. 2) before** you come to the park (same day) to hear the message about trail availability. Availability of the trails may change as conditions change.
2. Hours of operation are 9:00 am to sunset. During the pheasant hunting season (fall) the hours of operation are 2:00 pm to sunset.
3. It is illegal to operate an ATV, UTV or OHM while under the influence of alcohol or other drugs.
4. You cannot operate in a careless, negligent or reckless manner so that it endangers a person or property. This applies on the trails and in the parking lot.
5. Do not operate at unreasonable or improper speeds. Operators must slow to 10 MPH or less when riding within 100 feet of a person on foot. The parking lot speed limit is 10 MPH. The beginners' loop speed limit is 10 MPH.
6. All ATV and UTV operators and passengers under age 18, and **ALL OHM** operators and passengers, must wear a minimum DOT standard ATV or motorcycle helmet and have the chinstrap fastened.
7. Stay on marked trails. Trails are generally flat with many sharp turns and are one-way unless marked two-way.
8. ALL ATV/UTV/OHM must have US Forest Service approved spark arrester with muffler not exceeding 96 decibels.
9. Any vehicle bringing ATV/UTV/OHMs into RBSRA must have a valid daily or annual state park vehicle admission sticker. You may purchase vehicle admission at the park office or at the self-registration station. Failure to purchase vehicle admission may result in a citation.
10. Unloading of the ATV/UTV/OHM is permitted in the designated trail parking lot. If the lot is full, unload in the parking lot then park in Lot E on the other side of SUZ Rd.
11. Operation anywhere other than the designated trail (ex: gravel service roads, the runway, any road, campgrounds or in parking lots) is prohibited and may result in a citation.
12. While in the campgrounds, ATVs/UTVs/OHMs must remain on the trailer/truck bed.
13. Dune buggies, go carts, or other off-road vehicles (including trucks) are not permitted.

## OHM RULES

1. All OHM operators that are at least 12 years old and born after January 1, 1998, must possess a valid WI ATV/OHM combination safety certificate or valid certificate from another state or province. Proof must be carried with you.
2. Current WI ATV Safety course graduates must take the OHM Safety certification mini-course and carry proof of certification.
3. **All** OHMs must be registered and display current Wisconsin registration decals, affixed to the exterior and clearly visible at all times. This includes all DOT licensed dual-sport motorcycles. Five-Day and annual OHM non-resident trail passes are available online or at DNR license agents. Non-Resident ATV/UTV trail passes are not valid on OHMs.
4. All DOT licensed dual-sport motorcycles driven into RBSRA also require vehicle admission. (See General Rules #9)

## ATV RULES

1. All operators at least age 12 and born on or after January 1, 1988, must possess an ATV Safety Education Certificate, and proof must be carried with you. No safety certificate is required for children under the age of 12 while operating a small ATV (130cc or less) if they are accompanied\* by a designated adult.
2. All ATVs must properly display current Wisconsin registration decals or non-residents must display valid non-resident trail pass. Non-resident ATV trail pass is not sold at RBSRA.
3. All ATVs are required to be registered for public use and shall have a plate attached to the rear of the vehicle displaying the registration ID number. *See regulations for specifics.*
4. ATVs 50" wide or less, dry weight of 900 pounds or less, with 3 or 4 low pressure or non-pneumatic tires, and a seat designed to be straddled, can be ridden on the trails.

## UTV RULES

1. All operators at least age 12 and born on or after January 1, 1988, must possess an ATV Safety Education Certificate, and proof must be carried with you. Only certified operators may transport passengers.
2. Children between age 12-15 may operate small UTV (200ccs or less) on the trail **only** if accompanied\* by a designated adult **and** possess a valid ATV safety certificate.
3. No person may operate a UTV unless each passenger has their seat belt properly fastened.
4. All UTVs must properly display current Wisconsin registration decals or non-residents must display valid non-resident trail pass. UTV trail pass is not sold at RBSRA.
5. All UTVs are required to be registered for public use and shall have a plate attached to the rear of the vehicle displaying the registration ID number. *See regulations for specifics.*
6. **Advisory:** UTVs with a width over 50" may not fit on RBSRA trails.

\* **Accompanied** – Subject to continuous verbal direction or control, but not necessarily on the same machine.
