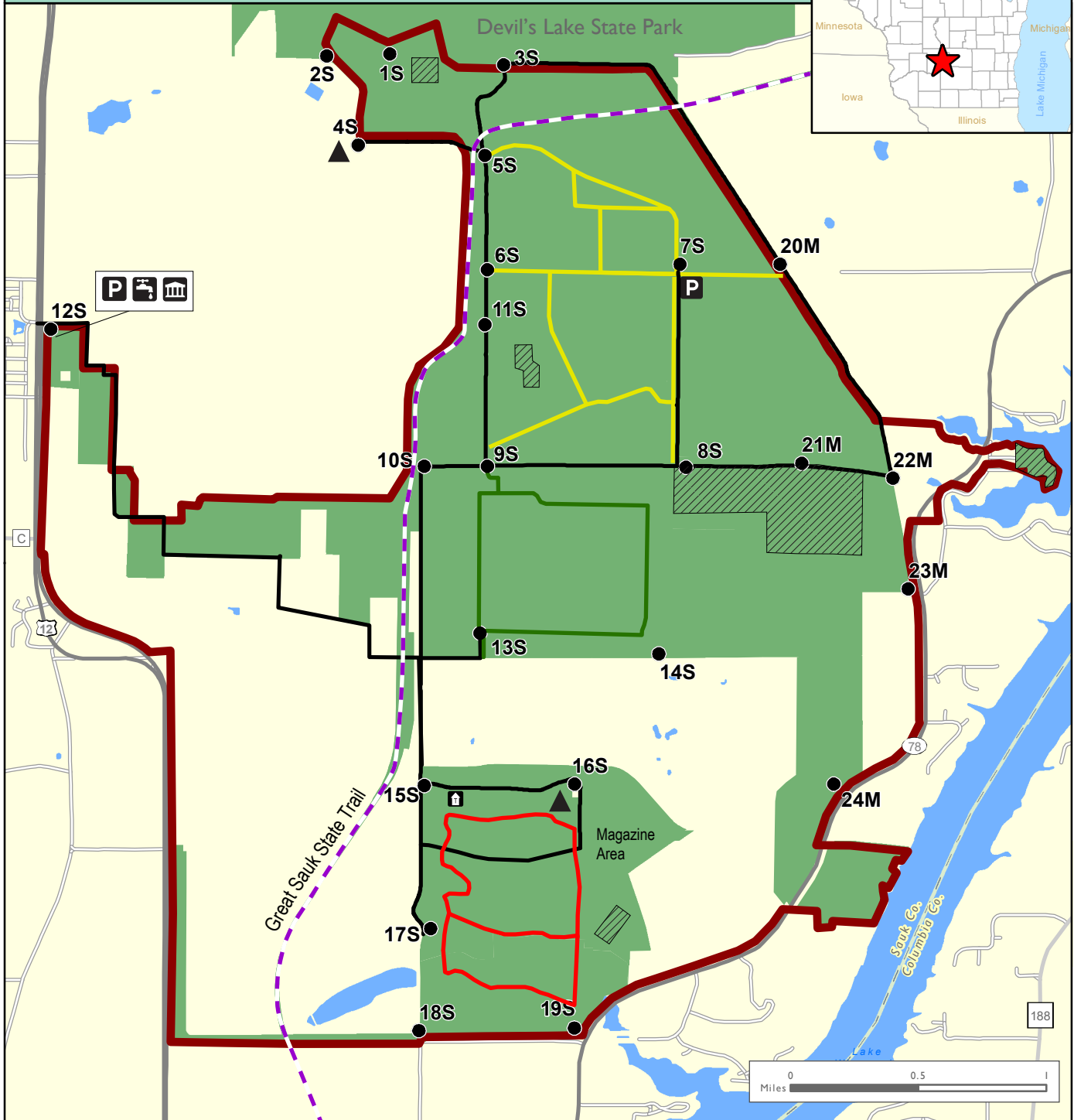


Sauk Prairie State Recreation Area (SPRA)

WELCOME to the SAUK PRAIRIE RECREATION AREA (SPRA)

Information provided is subject to change due to the ongoing master planning process.

ACTIVITIES AND ACCESS

1. The SPRA is open daily from 6 a.m. to 11 p.m.
2. Visitors may hunt, trap, hike, bird watch, pick mushrooms and berries, study nature, take photographs and other traditional outdoor activities. No fishing opportunities are available.
3. Visitors may drive, bike or ride horses on the subset of roads within the complex that are open. Roads are in variable condition; some have many ruts and potholes. Intersections are unmarked and motorists will need to yield at all crossings. Speed limit on all roads is 25 mph.
4. The public may access the Sauk Prairie Recreation Area at the main gate on USH 12.
5. All parking and traffic regulations apply. Vehicles shall be operated only on those roads designated as open on the attached map and parking is permitted only in established parking areas and shoulders of established roads. No parking or driving in fields is allowed. The property roads are not maintained for winter travel.
6. There is a seasonal public drinking water faucet available on the west side of the Museum of Badger Army Ammunition near the main entrance. Restrooms are available when the museum is open. The museum is typically open Tuesday-Saturday 10 a.m. to 4 p.m. Dates and hours may vary.
7. Pets must be leashed and under control between April 15 and July 31.

OPEN AND CLOSED AREAS

1. Many of the SPRA lands owned by the DNR are open, but some areas remain closed to public access due to safety issues (see map on reverse side). No entry into these areas for any purpose is allowed.
2. The old Pump House facility and the associated parcel on Lake Wisconsin remain closed due to safety issues.
3. The **Ho Chunk Nation** lands located in the northwestern section of the former Badger Army Ammunition Plant are closed to the public.
4. **USDA Dairy Forage Research Center lands are closed to the public.** The Research Center has agreed to allow public access across their land so that visitors can access the interior and southern block of DNR land.
5. **Please respect the Dairy Forage Research Center's operations and refrain from entering areas and roads that are closed. Future access through and to these lands may be dependent upon the public's adherence to these rules.**

HUNTING AND TRAPPING

1. Hunting is allowed starting the Saturday closest to October 17 through the second Spring Turkey period. Hunting is also allowed during Learn to Hunt, Youth Hunt, and Hunters with Disabilities seasons.
2. Trapping is allowed November 15 and continuing until February 15. All types of traps are allowed except in the Magazine Area, where only enclosed trigger traps (sometimes referred to as dog-proof traps) are allowed.
3. Hunting and trapping are allowed within 100 yards of designated trails, **except the Great Sauk State Trail.**
4. All legal firearms and trap types for hunting and trapping in Sauk County as well as bow and arrow will be legal during this time period. This includes shotguns, muzzleloaders, handguns and rifles. Please see the appropriate regulations pamphlet for further information on legal weapons and traps.
5. Daily hunting and trapping hours are listed in the regulations pamphlet. Hunters and trappers may enter the property no more than one hour before their legal hours and the property closes at 11:00 P.M.
6. Some areas of the property are posted as closed areas (see map on reverse side).
7. **It is illegal to hunt within 50 feet of the roadway's center or discharge a firearm or shoot an arrow from a bow from or across a park road. It is illegal to shoot within 100 yards of a building devoted to human occupancy.**

Caution: Please be aware of closed areas and potential hazards from construction debris and demolished structures. In addition, the Wisconsin National Guard continues to conduct field exercises that may close certain areas.
